ORDER

AND WHEREAS, the matter was placed in 259th Meeting of WRC held on September 21-23, 2016 and the Committee decided that "... Institutions which have requested for reducing intake may be permitted."

AND WHEREAS, a letter was submitted by the institution on 11.11.2016 with a request for closure of one unit of B.Ed. course from the academic session 2016-17.

If institution contravenes any of the conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Now, therefore, the intake of the institution for conduct of B.Ed. course is hereby permitted to reduce . the intake of 100 students (2 basic units) to 50 students (one unit.)
